Why do you think the nominee deserves this award?

In looking at the eligibility criteria for this award, Dr. Izadi not only meets but embodies each of the skills and characteristics outlined. It is evident in every interaction with him that he loves interacting with learners, is adept at crafting positive learning environments, and considers the opportunity to teach a deeply held privilege. As is evidenced in his CV, Dr. Izadi has consistently pursued leadership opportunities that prioritize the development or improvement of learning and mentoring communities throughout his career. In terms of enthusiasm for teaching, crafting a positive and encouraging learning environment, and acting as a professional role model there are few compare. Dr. Izadi is genuinely a special resident whom medical students hope they get the chance to work with and learn from. I cannot think of anyone more deserving of this award.

How has the nominee demonstrated passion and enthusiasm for teaching?

As already mentioned, his passion and enthusiasm for teaching are extensively qualified by the numerous leadership roles and awards outlined in his CV. Furthermore, his dedication to the culture surrounding teaching and learners is demonstrated most obviously in his enthusiasm to take on learners and teach regardless of the immense workload inherent to residency. He looks for any and all teaching opportunities to engage students whether surrounding post-operative management of esophagectomy patients, how to be a successful intern, or just how to maintain positivity through the grueling process of medical training.

How has the nominee demonstrated a commitment to maintaining a positive, productive learning environment? The night before my surgery sub-internship, Dr. Izadi reached out to me personally to let me know how excited he was to have me on the team and wanted to answer any questions I may have had. It was not lost on me that a busy surgical resident whom I had never met took the time to welcome me, get to know me, and address my anxieties; something a resident had never done for me prior. I have many examples of Dr. Izadi truly integrating me into the surgical team, allowing me to feel comfortable making mistakes, and going out of his way to maximize my clerkship experience. This really set the tone for an exceptional clinical rotation where I underwent immense growth as a learner, galvanized my decision to pursue surgery, and found a resident that showed me the type of future resident I want to be. Outside of my own personal stories, many other medical students echo my experiences and sentiments. He has established himself as a pillar of the OHSU Dept of Surgery and is a billboard for the culture of positivity and learner inclusion that the OHSU Dept of Surgery is known for. How has the nominee demonstrated being able to provide effective feedback to learners?

Dr. Izadi's success in delivering learner feedback effectively is due to the foundation of rapport, trust, and transparency he builds with learners. In genuinely getting to know learners as whole people, taking a personal interest in their professional goals, and making a deliberate effort to include learners in the team he is able to give feedback that is perceived as constructive and genuine. Additionally, he gives feedback gently, in real-time, often, and early on in rotations. I find that this creates the culture that constructive feedback is truly to assist learners in their growth, and that positive feedback is genuine.

Please give an example of the nominee role modeling professionalism.

During my rotation our senior resident was out sick with COVID-19 and another resident was injured and unable to feasibly operate. Dr. Izadi did not hesitate in stepping up to assume a leadership role as a PGY2. Despite taking on more responsibility he remained dedicated to teaching, advocating for learning opportunities, and maintaining the welcoming and

positive learning environment he had established. I was impressed that despite having significantly less bandwidth and time, his priorities and values remained steadfast.
