Why do you think the nominee deserves this award?

Dr. Lindsey Zhang was unanimously nominated by general surgery faculty to be considered for the outstanding resident teacher award. Although I have only been at the University of Chicago for 18 months, many faculty who have known her throughout her entire career here have described her as a superstar resident, technically excellent, but perhaps, more importantly, a gifted teacher and mentor. She has been part of national educational projects surveying residents and identifying improvements to the surgical learning environment. She has reported her findings at major surgical educational conferences. She works incredibly well as a leader of the residency program but then is also approachable for the medical student who is facing challenges on the surgical rotation. Dr. Zhang exemplifies every aspect of a model teacher. She is a star resident, and a trusted colleague and friend.

How has the nominee demonstrated passion and enthusiasm for teaching?

Even as a junior resident, Dr. Zhang demonstrated tremendous enthusiasm for teaching. She quickly and quietly took students under her wing, to teach them where to go and what to do in the foreign environment of the hospital wards. Once she ascended the ranks of her residency, Dr. Zhang became the obvious "go-to" for residents seeking mentorship and advice, oftentimes even for those senior to her. She gives every teaching opportunity her full attention. I often see that she leads teaching sessions for interns and juniors during down time between cases or before clinic, using diagrams on the resident office white board to demonstrate key points. Dr. Zhang does not seek notoriety for her efforts, but rather makes a difference for every single individual whom she encounters.

How has the nominee demonstrated a commitment to maintaining a positive, productive learning environment? Beyond the individual level, Dr. Zhang has a passion for improving the learning environment in general. During her research time as a Clinical Scholar at the American College of Surgeons, Dr. Zhang conducted a survey study of residents, and described the degree of bullying experienced by surgical residents nationally. She went on to study how specific aspects of a surgical learning environment affect resident well-being, and further how this related to resident burnout. Her work has been featured in JAMA, the American Journal of Surgery and Annals of Surgery. There is no question that Dr. Zhang will continue to be a leader in improving the learning environment for future generations of surgeons.

How has the nominee demonstrated being able to provide effective feedback to learners?

In the role of administrative chief resident, Dr. Zhang is the de-facto lead teacher of the residents. She is the confidant for anyone struggling or needing advice, and serves as the liaison for those issues to the program director and administration. This is a challenging role, but Dr. Zhang has effortlessly taken this on as part of her duties. Earlier this year, there was an intern struggling significantly with taking feedback on our service. I discussed this issue with Dr. Zhang, who was not on our service at the time, who then thoughtfully approached the intern and provided them with pointed feedback and a plan for improvement. I was so pleased to see this intern again recently, now flourishing and having remedied the issues she struggled with earlier. This success is a testament to Dr. Zhang's ability to connect with her colleagues. Please give an example of the nominee role modeling professionalism.

Dr. Zhang is the consummate model of professionalism. As an attending, I have had a number of challenging complications, several of which were shared with Dr. Zhang when she was on our service. Dr. Zhang recently presented one such complication at our weekly morbidity and mortality conference. There were several services involved in the care of the patient, and Dr. Zhang presented the complication with poise and grace, never shifting blame to anyone. She is such a

tremendous model of professionalism for the junior residents learning from her, who will no doubt emulate her positive attributes. In fact, her peers honored Dr. Zhang with the Hanns Frimpong Spirit in Surgery Award in 2021. This award, by vote of their peers, highlights one resident each year who exemplifies the values of compassion, enthusiasm and dedication to patients and the field of surgery.
