Surgical Education Week (April 10-15) will occur in San Diego for meetings at the Hilton Bayfront. The 2023 Joint Meeting of the ASE and APDS focuses our attention on the multiple opportunities and challenges of surgical education in the changing healthcare environment which provides a wealth of new opportunities and challenges.

Please block off April 10-15, 2023 now and begin to make your flight reservations.

Roy Phitayakorn, Jeremy Lipman, and Brianne Nickel have done a terrific job in crafting creative educational components for our program. Everyone can plan with certainty on taking part in these sessions, and all planning will be made with optimal flexibility that is possible by having all plans based on the availability of BOTH in-person in San Diego and live streaming capacities. All APDS and ARAS content and selected ASE sessions will be available concurrently to both the live audience in San Diego and those using the live streaming option. **ASE and APDS are focused on your health and safety. We will be working with experts and local leaders to ensure a safe, healthy meeting. Last year, the range of responsible requirements for those registrants who plan to attend in-person reached requiring masking as well as written affirmation of vaccination status as part of your on-site registration. While we all hope for better days as to circumstances in San Diego this April, we cannot offer assurances that the results of our study of circumstances over the next 15 weeks will not bring us to adopt similar criteria this year. We will update you with more details when we are closer to the meeting. Again, no affirmation of vaccination information is needed from those participating only via live stream.**

On Monday, April 10, the APDS will again offer the APDS Program Directors Workshop, spearheaded by Course Directors Mike Truitt and Julia Shelton, an optional opportunity that most Program Directors find to be an indispensable element of Surgical Education Week. This program runs from Monday morning through Tuesday at 10:00 am and brings together key materials (plus a very valuable syllabus/workbook in electronic format) as well as practical experience, advice, and insights, and is equally appropriate for new Program Directors as well as serving as a refresher course for experienced PDs.

The APDS program kicks off at 12:00 pm with opening remarks from APDS President, Kyla Terhune, MD, MBA, FACS and Jeremy Lipman, MD, APDS Program Chair, followed by two APDS paper sessions. Tuesday continues with a Panel Session: We Tried, But It's a Match, with Tuesday concluding with the APDS Poster Session, and gathering to recognize Tom Fise, concluding his 35-year service as APDS Executive Director. The APDS program continues on Wednesday morning with a Breakfast Session 1—Letters from the Trenches, an APDS Paper Session, followed by the APDS Presidential Address from Kyla Terhune, concluding with Membership Report/APDS Business Meeting. Wednesday afternoon will feature 15 lunch workshops, 3 Tools of the Trade workshops, another APDS Paper Session, two APDS Pro/Con Panel Debates, and the APDS Keynote Address from Jad Abumrad. Thursday morning continues with 10 QuickShot presentations, a Panel Session: OK Boomer on generational differences, and the morning concludes with the APDS Panel Alphabet Soup Session, with representatives of ECFMG, ABS, RRC, NRMP, and ERAS.

On Wednesday, April 12th ASE will begin with four pre-meeting courses – Mentorship and Leadership for Surgeon Educators Through Simulation, Fundamentals of a Career in Surgical Education (FASCE): Pathway to Clinician Education, Troubleshooting Your Clerkship, and Fundamentals of Teaching [separate registration required for each]. The main ASE Program meets Thursday, April 13th, all-day Friday, April 14th, and concludes at 12:30 pm on Saturday, April 15th.

Beginning on Thursday at 12:00 pm, the ASE portion of the meeting will get underway with Welcome Remarks from ASE President, Dimitrios Stefanidis, MD, PhD ASE Program Chair, Roy Phitayakorn, MD, MHPE followed by the ASE Panel Session discussing Ready or Not—EPAs in General Surgery Residency and the Plenary Paper Session, an additional Panel on Establishing a Global Surgery Experience for Surgical Residents and Students, and concluding with the Royce Laycock Lectureship. Additional ASE programming begins Thursday morning with Coordinator Track Program, SELF, and SERF. The day will continue with the ASE Poster Session, Reception, and the Candlelight Session. Friday morning opens with three concurrent ASE Podium Sessions, the ASE Presidential Address, two additional rounds of concurrent podium sessions, Friday's lunch will have the perennial and ever-popular "Thinking Out of the Box" luncheon (no fee to attend, boxed lunch available for separate purchase). On Friday afternoon, ASE and SEW attendees will have their choice from a schedule of workshops and trainee Quickshots sessions, concurrent with SERF Forums, and followed by the ASE Awards Banquet. Saturday morning will begin with concurrent podium sessions, the J. Roland Folse Lectureship, a Plenary Session, and ASE Panel III—Capitalizing on Community & Collaboration for Innovation in Surgical Education. The ASE program concludes with Closing Remarks and Announcements.

The ARAS program starts Monday morning with the ARAS New Administrators' Workshop, and an evening ARAS Welcome Reception for all ARAS registrants. The main ARAS program begins Tuesday at 8:00 am with ARAS President, Brianne Nickel, followed by ARAS Ad-Hoc Group Updates, a presentation on Planning & Strategy on Virtual Site Visit, an ARAS Panel on Program Administrator Development, and a presentation on "Rising from Tragedy, and afternoon Panel Session, a presentation on Program Administrator Mental Health and, 3 ARAS breakout sessions, and presentations on Essential Archiving Tools, and comments on EPAs. Wednesday will consist of lectures on TAGME, SCORE, and EQIP, features on problem residents, URM mentoring, and journal clubs, and the ARAS Presidential Address by Brianne Nickel, C-TAGME. Wednesday's education will continue with ABS and ACGME updates, teamwork (ARAS President-Elect Hemali Shah), and interviewing methods. Wednesday will conclude with ARAS registrants participating in the Joint APDS/ASE/ARAS/CCSE Reception. Thursday's morning wrap-up session includes talks by Stephanie Taylor on Global Surgery Rotation in a Community-Based Program, and by Laura Huth on Supporting Preliminary Surgery Residents.

Registration details are enclosed. You can register for one group's meeting or choose the single fee option which entitles you to attend any and all regular ASE, APDS, or ARAS events from Tuesday through Saturday at noon. Separate registration is needed for the APDS New Program Directors Workshop, the ARAS New Coordinators Workshop, and/or any of the ASE Wednesday and Thursday morning workshops.

We hope that you will find Surgical Education Week 2023 informative and motivating. We know that you will enjoy spending time with your fellow surgical educators, and we look forward to seeing you in San Diego.

ASE Thinking Out of the Box Luncheon

On Friday, April 14, the ASE Assessment, Curriculum, and Evaluation Committee will sponsor a forum for the brief presentation of creative ideas which are educationally sound, but which may not have undergone rigorous analytic proof of efficacy. The idea is to have members share creative ideas that have worked for them. The forum will be held during the lunch hour and is available to ASE/SEW registrants. For those who wish to secure a box lunch, that will be provided by a separate ticket purchase. The cost is \$50. There is a line on the registration form to register for lunch. Lunch ticket purchase is only required for a boxed lunch and the session is open to all registered attendees.

ASE Troubleshooting Your Clerkship

This pre-meeting course is an annual venue for new and continuing surgery Clerkship Directors and Coordinators to teach and learn all aspects of the surgery core clerkship in undergraduate medical education. This one-day program will include a panel discussion, half-hour topic areas with discussion, and three 15-minute updates after lunch. The four content areas will be:

1. Preparing the students for clerkship
2. The virtual world of clerkships education
3. The clerkship environment
4. Student and Clerkship Director support (accommodations, student support, and wellness)

Between sessions, there will be smaller sessions giving updates relevant to Clerkship Directors and Coordinators. In addition to the four content areas, the course will include updates for ASE/ACS Medical Student Core Curriculum; NBME Workgroup; and, WISE MD.

ASE Mentorship and Leadership for Surgeon Educators Through Simulation

Methods

Simulation is an effective method to teach leadership and mentorship skills through experiential learning and deliberate practice. This course will present important leadership, mentorship, and coaching concepts and corresponding skills using a combination of didactic content and simulation-based activities. Skills to be practiced in the simulated environment include mentorship, coaching, communication, conflict management in difficult situations, and managing emotional intelligence. Learners will practice and respond to simulated scenarios in a safe but challenging environment designed to manage their own emotions while interacting with a trainee or staff member under various clinical circumstances. Participants will evaluate aspects of team performance to differentiate effective and ineffective methods in relation to leadership, mentorship, and coaching.

Conclusion

Leadership, mentorship, and coaching skills are essential to the surgeon and can be both learned and practiced in a small group setting using simulation. Becoming an effective leader will enhance teaching ability and communication with staff and patients. Upon completion of this workshop, participants will be able to apply these skills to their daily workflow regardless of their current leadership role.

ASE Fundamentals of a Career in Surgical Education: Pathway to Clinician Educator

This course is designed to give the participants the fundamentals to get started in an academic career in surgical education. Designed to meet the career needs of all levels from residents to junior faculty, this course will offer tangible strategies and lessons learned from leaders in Surgical Education. This course will define an academic surgery educator (job description), describing the necessary educational skills to obtain, overcome challenges, develop tools to promote skills and achieve academic productivity. The course will highlight the various opportunities and resources available to develop an academic career in surgical education. Working groups will be used to facilitate discussion and the development of a teaching portfolio.

Course Features:

Pathways to Clinician Educator Leadership –

1. Expert panel
2. Overcoming setbacks/failure
3. Case-based presentations from course participants

Academic Productivity –

1. Explain the fundamentals of educational research
2. Discuss ways to get support for educational research
3. List credible publications/venues for educational projects/presentations
4. Describe strategies for scholarly productivity
5. Identify institutional and national resources to support educational research

Teaching Portfolio –

1. Prepare a teaching portfolio
2. Discuss the usefulness of a teaching portfolio for professional development
3. Integrate the aims of a teaching portfolio with personal academic goals and needs
4. Describe the tenets used for academic promotion
5. Illustrate the type of activities and credentials needed to fill in each of the tenets
6. Recognize available resources to build up a CV and a personal statement of education

ASE Fundamentals of Teaching

This highly interactive half-day pre-meeting course uses a case-based approach to the fundamentals of teaching. It is designed for those taking on a new teaching role or who would like to enhance their abilities as a clinical teacher. The session will cover teaching in the operating room, giving feedback, and using simulation. Participants will leave with new skills, knowledge, and energy they can apply to their learners.

Objectives:

1. Apply scaffolding to a surgical procedure
2. Employ goal setting for a clinical encounter
3. Contrast reinforcing and redirecting feedback

APDS New Program Directors Workshop

The New Program Director's Workshop will be offered before the APDS meeting. This will take place on Monday, April 10, from 7:00 am to 5:30 pm, and on Tuesday, April 12, from 7:00 am to 10:00 am [separate registration required]. The dynamic workshop will include a review of key ABS, RRC, ACGME, and other requirements impacting surgery residency programs.
